

Additional Services Terms And Conditions

## ADDITIONAL SERVICES TERMS AND CONDITIONS

These Terms and Conditions shall apply exclusively to the activity of registered Company's Customers and establish conditions for using services provided by the Company by means of "My Account" not stipulated by separate regulatory documents. These Terms and Conditions supplement the Customer Agreement.

The right to interpret the provisions of these Terms and Conditions as well as the right to modify the interpretations belong exclusively to the Company. Any other interpretation of the Terms and Conditions given by the Customer or non-compliance with these terms, conditions and procedure shall be unacceptable.

## TERMS AND DEFINITIONS

- **1.1. Company** means the party to the Customer Agreement that provides services to a Customer.
- **1.2. Customer** means the party to the Customer Agreement, an individual or a legal entity who/which uses the services provided by the Company.
- **1.3. My Account** means technological and interface solutions offered by the Company on the official Company website to enable the Customer to take full advantage of his or her rights and obligations under the Customer Agreement. "My Account" enables the Company to identify the Customer, and the Customer to use all Company's products and services available in "My Account".
- **1.4. Additional Services** are services provided to the Customer by the Company after the Customer has paid for their activation in size and procedure established by the Company.
- **1.5. Master Account** means the account that the Company provides to the Customer and which has its own identification number. The Customer's funds deposited in the Master Account may be used through "My Account" interface facilities to pay for various services offered by the Company.

## **GENERAL PROVISIONS**

- **2.1.** These Terms and Conditions define conditions for obtaining any services by the Customer under the Customer Agreement, the provision of which is not stipulated by the Company in separate regulatory documents.
- **2.2**. The Customer purchases Additional Services using "My Account" functionality and pays for their activation by means of his/her Master Account.
- **2.3.** The Company shall make every effort to provide high quality and timely Additional Services to the Customer, however does not guarantee their failure-free provision.
- **2.4.** The Customer fully agrees that the Company is not liable for any adverse consequences or losses incurred to the Customer in respect of the Additional Services provided by the Company.
- **2.5.** Detailed information on the procedure for providing each Additional Service is available on the Company website. Moreover, the Customer fully understands that such information has the same legal force as these Terms and Conditions.
- **2.6.** The conditions for providing Additional Services available on the official Company website may be changed by the Company unilaterally. The Company shall notify the Customer of any changes by publishing news on the official website or in any other way (through "My Account" functionality).
- **2.7.** The Company is entitled to modify these Terms and Conditions notifying the Customer by publishing news on the official website or in any other way (through "My Account" functionality).
